**Application Procedure:** The Arts Market is a producer-only event (artists must create what they sell). Artists are selected by a jury of local arts and crafts professionals, who base their decisions on the quality and originality of the work submitted. The Arts Market jury meets quarterly. Potential Arts Market artists must submit an application completed in full, application fee of \$20, 5 slides or photographs and 2 actual examples of each medium intended to be sold. Artwork must be submitted as it would be displayed and sold at the Arts Market; no unfinished or in-progress works are eligible for review. You may hand deliver application and artwork if more convenient. It will be your responsibility to retrieve your artwork after jury review.

**Application Fee:** \$20.00 made payable to the Arts Council **Participation Fee:** \$30.00 per booth space (10' x 10') per market.

**Booth Display:** Artists must provide a suitable, outdoor display for work, no larger than 10' x 10'. Tent is optional.

**2 Artists Applying:** 2 artists may apply together only if both applicants collectively had a hand in creating every piece submitted (please attach a brief explanation on the nature of the collaboration), otherwise artists must apply separately.
